Assisted Places at St Teresa's Preparatory and Senior Schools

No parent within the catchment area of St Teresa's need feel that they cannot afford to send their daughter to study here.

In line with Charity Commission public benefit guidelines, the Heads and Governors of St Teresa's School are delighted to inform you of the financial provision for parents who might be unable to pay the fees to have their daughters educated at St Teresa's.

St Teresa's is a school with a Catholic Foundation but welcomes girls of all religious denominations and from a wide range of ability into its academically successful, caring and supportive environment.

A number of Assisted Places are now available for new girls joining classes from Year 3 in the Prep School and Years 7 to 12 in the Senior School.

All new applicants to the school are eligible to apply for these awards which are subject to a means-tested review of a family's financial circumstances. The selection and award of places will be at the sole discretion of the school.

Please note that the discounted fee applies only to the tuition fee and not the boarding fee.

Assisted Places at St Teresa's Preparatory and Senior Schools

What are these places?

A number of Assisted Places are now available annually for new girls joining St Teresa's. There is one place available from Year 3 in the Prep School and three from Year 7 to Year 12 in the Senior School. The decision to award these places is based upon the financial circumstances of the family and fees remission may be as much as 100%.

Who can qualify?

- *With a gross assessed family income of £25,000 per annum or less, your daughter could be eligible for free education at St Teresa's.*
- *If total assessed family income exceeds this figure on a sliding scale up to*
- *£50, 000, fees remission paid by the school will be as follows:*
- *Gross assessed family income between £25,000 - £35,000 = 75% fees relief*
- *Gross assessed family income between £35,000 - £50,000 = 50% fees relief*

All girls wishing to join the Senior School in Year 7 or above will also be required to have been successful in our Entrance Examination.

How do I apply for an Assisted Place at St Teresa's?

If you would like your daughter to be considered for an Assisted Place please simply **complete our standard Registration Form** which is available on our website www.stteresasschool.com or from our Admissions Registrar on **01372 750204**

You will then be invited to bring your daughter either for an assessment day (from Year 3 to Year 6 in the Prep) or to sit our Entrance Examination (for places in Years 7 to 10). Entry to Year 12 will be based upon interview and academic ability. Girls wishing to apply for an Assisted Place in Years 7 to 10 will be required to sit the Entrance Examination in the January prior to September entry alongside all other applicants to the school. Those wishing to apply for an Assisted Place from Year 3 in the Prep School will be required to attend an assessment day in January.

Although financial assessment will take place only after a girl has been awarded a conditional place, please **complete and return the Confidential Statement of Financial Circumstances Form with your application.** This form is also available on our website or from our Admissions staff.
